

## **CONSENT AND RELEASE**

I am the parent or legal guardian of \_\_\_\_\_ (my “Child”) and have the authority to provide this Consent And Release on behalf of my Child, in connection with my Child’s participation in the “Every Child Matters: Education Through Reconciliation” (working title) event hosted by the University of Manitoba on behalf of the National Centre for Truth and Reconciliation (“NCTR”) and the Aboriginal Peoples Television Network (“APTN”). The University of Manitoba, NCTR and APTN are collectively referred to below as the “Producer”.

I give my consent and agreement to all of the following:

### **A. Permission To Participate**

1. My Child may home-record a video, not to exceed 30 seconds, that features my Child describing what Reconciliation means to them (the “Video”). I agree that the Video will start with my Child stating his/her name, age, and general location (city, town, etc.).
2. Regarding the content of the Video, I will ensure that: (a) my Child is not wearing any clothing or using any props which include known logos, for example T-Shirts or caps with band names, super-heroes, cartoon characters, etc.; and (b) my Child is not performing, nor in any way including, any existing recorded music.
3. My Child may upload the Video, together with a copy of this signed Release, to <https://reconciliationandme.portal.massive.app> (Upload password: NCTR2021) where it will be assessed by a panel comprised of representatives from NCTR, APTN, among others.

### **B. If My Child’s Video Is Selected**

1. I agree that the Video may be exhibited over the internet, from the APTN website, the NCTR website, among other websites, and potentially televised on the APTN network during the “Every Child Matters: Education Through Reconciliation” event being held during the last week of September, 2021.
2. While it is not anticipated that the Video will be edited, I agree that the Producer may edit the Video to the extent it deems necessary for exhibition/telecast purposes.

### **C. If My Child’s Video Is Selected As One Of The Six Best Submissions**

1. I agree that my Child may participate in a professionally filmed rendition of the message included in the Video (the “Professional Video”). I acknowledge that the Professional Video will also include my Child’s name, age, and general location.
2. I agree that the Professional Video may be exhibited over the internet as well as televised over the APTN network, an unlimited number of times.

3. I agree that my Child may participate in a hosted video conference (Zoom or Skype, etc.) and acknowledge that this video conference, in whole or in part, may be available on the internet and may also be televised, in whole or in part, on the APTN Network, an unlimited number of times.

**D. Withdrawal of Consent**

1. I may withdraw my consent at any time prior to my Child's Video being exhibited over the internet or on television, and I understand that after the Video has been exhibited it can be taken down at my request but the contents will have been made public and out of Producer's control.

2. If your Child's Video is selected as one of the six best submissions you may notify us within \_\_\_ days that you do not wish your Child to participate in the Professional Video.

3. If you allow your Child to participate in the Professional Video you may advise us at any time prior to the hosted video conference that you do not wish your Child to participate in the hosted video conference.

**E. General**

1. I assign all rights to the Video to the Producer, and acknowledge that the Producer will own the worldwide copyright in the Video. Unless I withdraw my consent as described above, the Producer will have the exclusive reproduce, re-publish, or re-print the Video in any format or media throughout the world forever.

2. I understand that by signing this Consent And Release I cannot later bring a complaint or court action against the University of Manitoba, the NCTR, and/or APTN for infringement of my Child's right of privacy, infringement of my Child's moral rights (which I waive in favour of the Producer and its licensees, successors or assigns) or any other personal right.

**3. FIPPA Notice**

**Notice Regarding Collection, Use, and Disclosure of Personal Information by the National Centre for Truth and Reconciliation**

I acknowledge that my Child's personal information and any accompanying records are being collected under the authority of *The University of Manitoba Act* and *The National Research Centre for Truth and Reconciliation Act*. The information my Child provides will be used by the University for the purpose of participating in the Reconciliation & Me initiative, for communications, and for providing services offered by the National Centre for Truth and Reconciliation. Your personal information may be disclosed on the website, in publications, and as part of future educational programming as described above. Your personal information will not be used or disclosed for other purposes, unless permitted by *The Freedom of Information and Protection of Privacy Act* (FIPPA) or *The National Research Centre for Truth and Reconciliation Act*.
